Bureau Veritas Romania policy is fit for purpose, context, nature, scale and impact on the environment and occupational health and safety of its activities, is a framework for setting objectives of the organization.

Bureau Veritas Romania maintains and supports the vision, mission, values and policies of Bureau Veritas Group, as described in local policies.

Romanian and Bureau Veritas Group's policies are communicated to all employees, persons who working under the control of the organization and other interested parties by BV Romania website ([www.bureauveritas.ro](http://www.bureauveritas.ro)), intranet, mail, bulletin boards, training.

Vision of Bureau Veritas Romania is to become an important player in our industry, in order to deliver economic value to our clients by offering quality services, an accident free workplace, with no harm to people and continuously decreasing of environmental impacts of business activities, in order to continuous improvement of our services.

Bureau Veritas Romania, as part of the Bureau Veritas Group, in Romania, has organized its operations in five divisions: Marine, Industry (IND), Building & Infrastructure (B&I), Certification of Management Systems (CER), Commodities (CTD) : Government Services & International Trade & Consumer Products Services & Commodities Inspections & AGRI Testing (GSIT&CPS IAA&AGRI), Physical chemical Testing Laboratory and oil and petrochemical inspections (OPT), Mineral Metals and Fertilizer inspections (MMT&FER) and it is specialized in the services of:

- **Marine** (classification / certification and inspections for building of new vessels and ships in service, certification of naval materials and equipment, shipbuilding projects notifications and naval equipment, technical assistance and consultancy ),
- **Industry** (conformity assessment of industrial equipment, personnel certification, second and third party shop and site inspections, Technical expertise, in service inspections)
- **B&I**: Core Services Bureau Veritas (Technical Control in Construction for the decennial insurance under French law - NF P03-100, Technical audits of third / second party in construction; Assessment of technical condition of buildings, Technical assessment of construction books; Compliance inspection of executed works ; Assistance during the design, Third party verification of design projects for construction, Second party assessment of subcontractors; Quality Assessment / Quality control - QA/QC ; Assistance for project management- PMA) and Services in line with national regulation for buildings (H&S Coordinator, In service verification for construction and installation ; National Attested Site Inspector; National Attested Design Verification; National Attested Expertise)
- **Certification of Management Systems** (certification of management systems, second party auditing services based on customer-specific or Bureau Veritas standards),
- **GSIT&CPS IAA&AGRI** (Inspection before shipment and delivery, International Trade, Qualitative and quantitative commodity inspection, consumer goods inspection, Testing of cereals – Galati and Constanta laboratories,).
- **OPT** : Qualitative and quantitative inspections for oil and petrochemical products, Testing of petroleum products - subject to accredited methods, treated water, process waters, chemical agents at workplace and emissions, within the Petrobrazi refinery laboratory
- **MMT&FER : Inspection of metals and minerals, Fertilizers**
